The panel producer demonstrates conformance to the formaldehyde emission requirements defined in 40 CFR §770.10 and 40 CFR §770.17(c)

At least three (3) months of routine quality control test data was collected and analyzed to verify conformance to the criteria defined in 40 CFR §770.17(a)(4) and 40 CFR §770.17(c).

The panel producer has been granted an exemption from third party certification as permitted in 40 CFR §770.17(b).

Composite Wood Products produced in accordance with the panel producer's NAF exemption are subject to the requirements  
specified in 40 CFR §770.10 through 40 CFR §770.45 except as otherwise specified in 40 CFR §770.17(d).

The validity of this certificate is subject to the requirements defined in 40 CFR §770.17 and the terms of the service agreement held between BMH and the panel producer.
