At least six (6) months of routine quality control test data was collected and analyzed to verify conformance to the criteria defined in 40 CFR §770.18(a)(4) and 40 CFR §770.18(d).  
The panel producer has been granted an exemption from third party certification as permitted in 40 CFR §770.18(b).

specified in 40 CFR §770.10 through 40 CFR §770.45 except as otherwise specified in 40 CFR §770.18(e).
