Laminated Products (Veneer Core): 4.0mm – 19.0mm

Initial (qualifying) tests conducted by the Third Party Certifier (TPC) were completed as required in 40 CFR §770.18(a)(3).

At least six (6) months of routine quality control test data was collected and analyzed to verify conformance to the criteria defined in 40 CFR §770.18(a)(4) and 40 CFR §770.18(d).
The panel producer has been granted an exemption from third party certification as permitted in 40 CFR §770.18(b).

Composite Wood Products produced in accordance with the laminated product producer's ULEF exemption are subject to the requirements specified in 40 CFR §770.10 through 40 CFR §770.45 except as otherwise specified in 40 CFR §770.18(e).

The validity of this certificate is subject to the requirements defined in 40 CFR §770.18 and the terms of the service agreement held between BMH and the laminated products producer.
