CANFER DECLARATION OF CERTIFICATION NAF-EXEMPT PANEL MANUFACTURER TPC-2/CANFER/NAF/0721303

Relating to Benchmark Holdings, LLC (BMH) qualification of producers of composite wood products made with No-Added Formaldehyde (NAF) resins according to Canada Formaldehyde Emissions from Composite Wood Products Regulation, hereinafter, "CANFER" (SOR/2021-148) and Chapter 40, United States Code of Federal Regulations, Part 770.17 (40 CFR §770.17)

Green River Panels (Thailand) Co., Ltd. ***EPA CDX TPC-RTA-456305***

BMH has received a completed application for NAF exemption submitted by the above-named panel producer of composite wood products in accordance with CANFER §10(1), 40 CFR §770.2(e) and §770.17(a).

The panel producer demonstrates conformance to the formaldehyde emission requirements defined in CANFER §6 and §10(3) as well as 40 CFR §770.10 and 40 CFR §770.17(c) for composite wood products within the panel producer's scope of the BMH-approved NAF exemption at:

Particleboard (PB): 9.0mm-36.0mm

Initial (qualifying) tests conducted by the Third-Party Certifier (TPC) were completed as required in CANFER §10(2)-§10(3) and 40 CFR §770.17(a)(3).

At least three (3) months of routine quality control test data was collected and analyzed to verify conformance to the criteria defined in CANFER §10(2), CANFER §10(3)(c), 40 CFR §770.17(a)(4) & 40 CFR §770.17(c). The panel producer has been granted an exemption from third party certification as permitted in CANFER §10(1), CANFER §10(4) and 40 CFR §770.17(b).

Composite Wood Products produced in accordance with the panel producer's NAF exemption are subject to the requirements specified in CANFER §10 and 40 CFR §770.10 through 40 CFR §770.45 except as otherwise specified in 40 CFR §770.17(d).

The validity of this certificate is subject to the requirements defined in CANFER §10, CANFER §19(3)(a), 40 CFR §770.17 and the terms of the service agreement held between BMH and the panel producer.
