



CANFER DECLARATION OF CERTIFICATION ULEF-EXEMPT PANEL MANUFACTURER

Relating to Benchmark Holdings, LLC (TPC-2) qualification of panel producers of composite wood products made with Ultra-Low Emitting Formaldehyde (ULEF) resins according to Canada Formaldehyde Emissions from Composite Wood Products Regulation, hereinafter, "CANFER" (SOR/2021-148) and Chapter 40, United States Code of Federal Regulations, Part 770.18 (40 CFR §770.18)

INDUSTRIA DE COMPENSADOS GUARARAPES (SANTA CECILIA)

BMH has received a completed application for ULEF exemption submitted by the above-named panel producer of composite wood products in accordance with CANFER §11(1)(b) and 40 CFR §770.2(e) and §770.18(a).

The panel producer demonstrates conformance to the formaldehyde emission requirements defined in CANFER §6 and §11(5) as well as 40 CFR §770.10 and 40 CFR §770.18(d) for composite wood products within the panel producer's scope of the BMH-approved ULEF exemption at:

RODOVIA BR 116, KM 142, BAIRRO INDUSTRIAL SANTA CECILIA, SANTA CATARINA 89540000

Hardwood Plywood Veneer Core (HWPW-VC): 8.2mm to 30.8mm made with PF resin

Initial (qualifying) tests conducted by the Third-Party Certifier (TPC) were completed as required in CANFER §11(2), CANFER §11(5) and 40 CFR §770.18(a)(3).

At least six (6) months of routine quality control test data was collected and analyzed to verify conformance to the criteria defined in CANFER §11(2), CANFER §11(5)(c), 40 CFR §770.18(a)(4) and 40 CFR §770.18(d).

The panel producer has been granted an exemption from third party certification as permitted in CANFER §11(1)(b), CANFER §11(6), and 40 CFR §770.18(b).

Composite Wood Products produced in accordance with the panel producer's ULEF exemption are subject to the requirements specified in CANFER §11(1), CANFER §11(5)-§11(8) and 40 CFR §770.10 through 40 CFR §770.45 except as otherwise specified in 40 CFR §770.18(e). The validity of this certificate is subject to the requirements defined in CANFER §11, CANFER §12-§26, CANFER §31, 40 CFR §770.18 and the terms of the service agreement held between BMH and the panel producer.
