specified in 40 CFR §770.10 through 40 CFR §770.45 except as otherwise specified in 40 CFR §770.18(e).

The validity of this certificate is subject to the requirements defined in 40 CFR §770.18 and the terms of the service agreement held between BMH and the panel producer.
